## WQA Offers Certification Opportunities

Can you answer these questions?

*How does counting plumbing fixtures help in water treatment?*

The kit, which includes four quizzes, can be done entirely on your own and mailed to the WQA for grading. Completion of all four quizzes earns you one credit toward certification.

## Water Conditioning License Exams Set for September

If you are interested in taking the Minnesota water conditioning contractor or installer's license test, you must complete the Department of Labor & Industry's application and bond information required by the state. Applications are available online at the DLI's new website, now located at [www.dli.mn.gov](http://www.dli.mn.gov). All paperwork must be completed and submitted by August 15, 2009, no exceptions. Please check the Department's new website for updates on the deadline, as they will not allow late paperwork.

It is suggested you submit your paperwork well in advance of the August 15 deadline. That way, if you are missing information, your application may be returned to you for revisions prior to the deadline. If you have questions, the DLI's website has all the information you need for completing the application.
