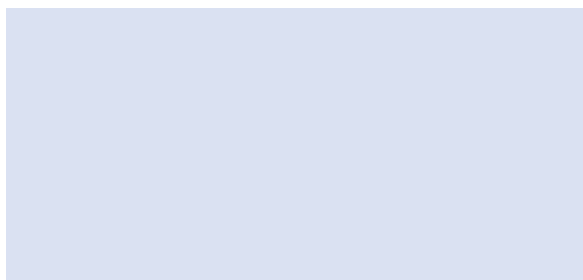
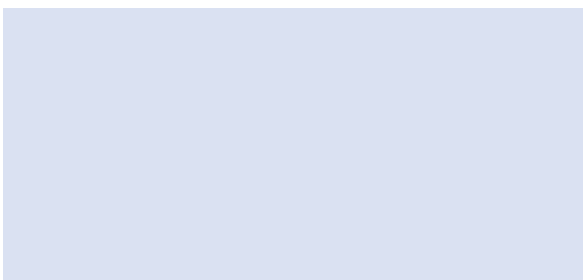

Be Sure To Register Unlicensed WC Installers

Registered unlicensed water conditioning installers can perform installations in single family homes without a licensed journeyman on the property. For many companies and many jurisdictions, this might seem to codify common practice. It actually raises the bar, however.

The law specifically requires a licensed Journeyman or Master to be responsible. The work order on site should have the name of the responsible Journeyman or Master listed. That individual must be available – that means answer the phone. The Journeyman or Master must also ensure the work is done properly – for the long term. His or her name should be recorded in the contractor's files.

Statutory Language on Supervision

Residential Work

Minnesota Statutes 326.555 Subdivision 1(b)

For single family residential units, when a registered unlicensed water conditioner is performing the work, a water conditioning master or journeyman must be

"available and responsible for ensuring all water conditioning work performed by the unlicensed individual complies with the applicable provisions of the plumbing and water conditioning codes, etc...."

This does not require the person providing the supervision to be on the premises, only to be "available and responsible."

Commercial Work

Minnesota Statutes 326.555 1(b)

For all other water conditioning work (e.g., multi-family and commercial), a registered unlicensed individual

"must be under the direct supervision of a responsible licensed water conditioning master."

Minnesota Statutes 326.50 defines "direct supervision to mean:

"a direct supervisor is present at the location where the registered unlicensed individual is working" and is "immediately available to the registered unlicensed individual at all times for assistance and direction."

Electronic supervision is prohibited for direct supervision by Minnesota Statutes 326B.50 subdivision 5.

Water Conditioning Installations

Must Do Basics

- Protect public health - downstream and upstream
- Installations should be completed with quality and appearance for long term use
- Provide value for the customer as contracted
- Work safely

Contractor Responsibility

- The water conditioning contractor, a business licensed in Minnesota, is responsible for all its activities
- Installers are responsible to know and perform all work to Minnesota Plumbing Code
- Plumbing permits must be obtained in jurisdictions where required.
- Plan approval must be obtained where required
 - o DJI approves commercial plumbing changes and inspects all Minnesota licensed facilities
 - o MDH reviews water conditioning systems for federally regulated small systems

Trades People Requirements

All installation work must be done by a trades person holding a

- a) Water Conditioning Master license, a
- b) Water Conditioning Journeyman license, or an
- c) Unlicensed Water Conditioning Registration

The Minnesota Department of Industry maintains a list at valid licenses available at <https://secure.doli.state.mn.us/lookup/licensing.aspx>

The Master holding the license for the contractor is responsible for all installation activities of the company.

Commercial and multi-unit residential installations may be done by a Master, Journeyworker, or by a registered unlicensed worker when a Master or Journeyworker is on the premises directly supervising the work.

Single family residential installations may be done by a Master, Journeyworker or a registered unlicensed individual. If a registered unlicensed installer is working without a Master or Journeyworker on site, a specific Master or Journeyworker must be (1) available to the installer by phone, text messaging or otherwise contactable and (2) responsible for the work performed. The Master or Journeyworker's name should be on the installing work order and recorded by the Water Conditioning Contractor.
